Founded by the Baptist Minister's Wives, for 40 years, Children's Village, Inc has provided shelter, food and clothing to Alabama's abandoned, abused and neglected children. We are located at 2001 18th Street, S. W., Birmingham, AL, and presently have two houses in which we house ten boys and eight girls from the ages 6-18. We are the only facility in Jefferson County that can accept male and female siblings and, as a result, have been able to keep sibling groups together.

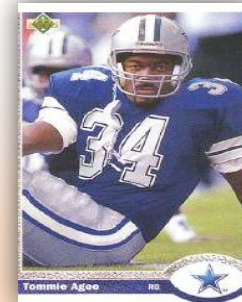

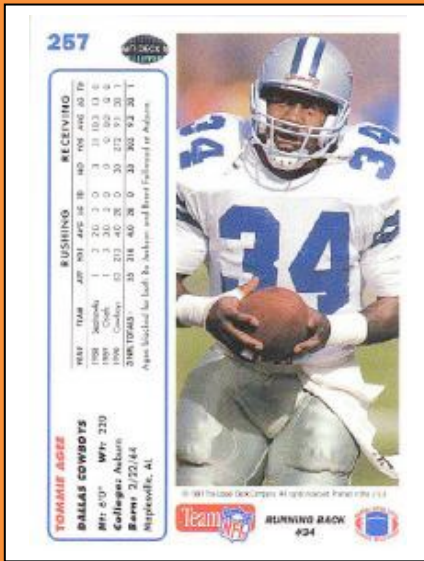

Tommie Agee

a native of Chilton County, Alabama, was a former professional running back for the Seattle Seahawks, the Kansas City Chiefs, and the Dallas Cowboys of the National Football League. Agee played college football at Auburn University, and was drafted by Seattle in the fifth round of the 1987 NFL Draft (the same year as fellow Auburn running backs Brent Fullwood, Bo Jackson, and Tim Jessie). Jackson gives credit for much of his college success to Agee, a great runner and blocker. After his career at Auburn, Tommie went on to play for seven years in the NFL for Seattle, Kansas City, and in two Super Bowls with the Dallas Cowboys. Agee was also a NFL special team player.
